STRENGTHEN U.S. BORDER SECURITY



- Adjudicated **11.7 MILLION** nonimmigrant visa applications
- Issued **9 MILLION** nonimmigrant visas
- Issued **462,445** immigrant visas
- Issued **373,431** student visas
- Issued **353,279** exchange visitor visas

We prevent unqualified applicants from gaining visas, while efficiently facilitating legitimate travel to the United States.



HELP CHILDREN

We have a special commitment to the world's most vulnerable citizens.

- Adoptions to the United States: **4,059** (FY2018)
- Adoptions from the United States: **81** (FY2018)

Preventing International Parent Child Abduction:

- Enrolled **4,732** children in the Children's Passport Issuance Alert Program (CY2018)

HELP U.S. CITIZENS OVERSEAS



- Registered **66,595** overseas births of U.S. citizens
- Issued **59,904** emergency passports overseas
- Responded to **27,282** welfare/whereabouts inquiries
- Assisted families of **11,911** U.S. citizens who died while overseas
- Conducted **10,920** visits to U.S. citizens in prison
- Published **1,666** emergency messages
- Repatriated **1,209** U.S. citizens

An estimated **9 MILLION** U.S. citizens live overseas.

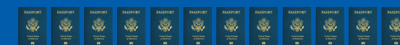


PROMOTE ECONOMIC GROWTH

- International visitors contributed **\$256.1 BILLION** to the U.S. economy (CY2018)
- International students contributed **\$45.3 BILLION** to the U.S. economy (CY2018)
- International travelers supported **1.2 MILLION** U.S. jobs (CY2018)
- 10 PERCENT** of all U.S. exports are related to travel and tourism (CY2018)



PROVIDE PASSPORT SERVICES



- Issued **20 MILLION** passports and passport cards
- 146 MILLION** valid U.S. passports in circulation
- 44.5 PERCENT** of U.S. citizens have a passport
- 29** domestic passport agencies and centers
- Approximately **8,200** passport application acceptance facilities nationwide
- 5.5 MILLION** inquiries addressed by the National Passport Information Center

PREVENT FRAUD

- 26,000** passport and **108,000** visa applications investigated by specialized fraud prevention experts
- Over **1,800** employees worldwide trained on advanced fraud prevention techniques
- Millions of visa applications analyzed to improve adjudications and fraud prevention efforts worldwide
